I think you need to know up front that my opinion is the MPB Opportunity provides the quickest, fastest way I have seen for the average, non marketing type to make money I have ever seen. The risk is virtually Zero which we will explain further.

I spent my first 10 years in the industry as a distributor,

I worked with 3 companies during that time and achieved success in each one. The next 10 years I worked in the corporate environment as VP of sales and marketing and I owned my own MLM company. The last 10 years I have operated Calvert Marketing Group which is a consulting, training, and seminar company. Many of my clients are Network Marketing companies, and six figure earners in various companies.

I have made over 3 Million dollars in a year after building a team of over 60,000 distributors. I have always measured my success based upon the success of people on my team.

I know of very few network marketing distributors who have developed more six figure income earners than I have over the years. I just say that so you know, that this information was written to support you and our team members.

I also have several other business interest in various markets, including Warehouses in Atlanta, an Ebay Training Company, and over a dozen other niche websites.

is a business my wife and I started as a partnership before we were married and operate today. She is a member of MPB and I support her. It goes without saying that we are not email blasting, or promoting this opportunity in any way to my current mlm client list. This is the closest I have come to being an actual distributor for any company in nearly 20 years.

We support the industry and are wholesale buyers with about a ½ dozen companies.

Please understand that I will document as much information as I possibly can, but the purpose of this publication is to give you my opinion based upon my background in the industry. I don't have a crystal ball. I can tell you that if I didn't feel confident this company would be here 20 years from now, and if it didn't offer six figure MONTHLY income potential, I would not be spending 1 minute of my time on it.

Where is the Controversy Coming From?

The short answer is Scared distributors in traditional grind it out MLM companies who are losing their downline members to MPB & quoting an article with outdated information from the MLM Watchdog. Quite frankly the controversy we have personally encountered has been minimal. Two people out of about 35 we have contacted. However our team is growing rapidly. So if 1000 team members each run into this twice, I can have 2,000 phone conversations or write this report once and make it available to our team.

Below is a rebuttal I initially wrote regarding the article, but please keep in mind **this was BEFORE the company introduced their "Retail Your Way to Success" program.** It is my understanding that this program was in development prior to the article being written, but not out to the field at the time it was written.

MPB Grocery Scam Rebuttal

I was asked by one of our members to respond to the post below written at The MLM Watchdog.

So that is what I am doing.

First let me say, that I enjoy the watchdog and agree with 90% of what is posted there. Over all they do an excellent job and provide a good service to the Network Marketing community.

Anyway, the best information they share, is the 3rd party court files, FDA and Attorney General information.

The rest is subject to interpretations, human bias, and opinions. Which is fine, nobody has a crystal ball and all we can do is share our opinions, which is what I am doing here.

So I am going to break down each statement of the article. (Please keep in mind everything you are reading was written by me and MLMWD prior to the introduction of the “Retail Your Way” to success program)

START OF ARTICLE:

MPB GROCERY SCAM

LET’S SEE, HAS A 2X2 MATRIX CYCLER EVER BEEN LEGAL?

HERE IS THE SALES PITCH

There at least a dozen 2x2 cycler’s in operation right now, the problem has not been the 2x2 but the fact that 90% of token products that people would not purchase if not for the commission plan, I don’t think the same can be said about groceries, do you?

- 1.Begin networking with experienced leaders by your side. Gain 2 personal sales - that's all every person has to produce. UNLESS YOU WANT TO GET PAID)**
- 2.Help those 2 get 2 for 6 total and you cycle. (FAT CHANCE SEE STATS BELOW)**

Rebuttal #1

I totally don't understand this statement, but 2 helping 2 would be applicable to any commission plan on the planet, wouldn't it be? That is what network marketing is about .. duplication. Only in most companies you need a lot more than 2 to share with 2 to ever create a profit.

3.Each cycle pays \$300.00 cash and a \$200.00 Walmart / Sams Club gift card. (WOW \$500 JUST LIKE OTHER 2X2 SCAMS)

4.Each time you cycle you move to the top of a new matrix. (GREED BUT UNLESS YOU HAVE A BIG LIST OF SUCKERS YOU WILL NEVER SEE THIS

What?

This comment is totally unnecessary and logically ridiculous. This really makes no sense. Name any network marketing organization. After you enroll 2 people what are you going to do? Do you stop? Do you help those people enroll people?

Do you continue to sponsor? This is NO different than any other program accept for the fact that you have the OPPORTUNITY to do it again! Call it greed or call it maximizing your income, I guess it just depends on your paradigm.

Some of you know that in 1999 I personally introduced a 3x3 comp plan and we also had a re-entry feature, I wish I was smart enough to add the follow me aspect. Regardless, the reason we did this was to maximize a distributors income.

Watch your matrix fill again and again with the same people. Over & over. (FAT CHANCE!)

Why is there a fat chance?

Is it unrealistic to think that people who are serious will continue to find 2 workers that will find 2? Of course not! If a person cannot reasonably expect to accomplish this, then they should be doing something besides marketing!

The truth is, people are accomplishing the above, over and over daily. Now that is the REALITY of the situation.

Additional Note, not part of original response.

At the time of this writing Dawn and I have been with MPB 3 weeks. We have only personally enrolled 12 people. 7 have already cycled and some are working on their 2nd & 3rd cycle. So the program is working, people are getting paid. In our 5th cycle 5 of the 6 people came from people on our team that had cycled, and only 1 slot was filled by a newly enrolled member.

Spillover qualifies for a cycle as long as you have 2 personal sales. (SPILLOVER? FAT CHANCE!)

The truth is you cannot be passed up by your downline because you are put in a “holding tank” and if someone passes you, or completes their first 2x2 before you do you still get credit after you have enrolled 2. This is a very unique feature and guarantees that unlike other 2X2 you cannot get left behind.

Sidenote As I read through this article again, it is almost like whoever wrote it has a personal vendetta against someone at MPB. They are pulling stuff out of the air, that basically applies to any mlm opportunity and trying to make the realities of building a business a big negative that only applies to MPB.

A 2x2 Matrix works and makes money for the company (in this case MPB) because the majority of the fools that jump in can't sign up 6 people. The average 2x2 Matrix Cyclor pays out about 14%. The Scam Company ends up FAT, Rich and Happy. That means that of every 100 people that join 14 get paid. That means in MPB case for every \$20,000 paid in only \$2,800 is paid out. HEY! With that kind of cash flow you can afford a great looking website like MPB

Maybe this is it, they are jealous of how good the MPV website looks. LOL

Cyclor programs are not for somebody that can't enroll 2 people, but you know what, neither is any other MLM program! This is the first time a company has taken a 2x2 mainstream. In the past they have always had worthless leads or digitally delivered resale rights ebooks.

Trim International, previously ran by Gary Calhoun generated complaints because of advertising paid for and no value received. This was a “We Automatically build your Downline” scam. This run created United Media Pro. United Pro Media The BBB has an F rating on United Pro Media (click below)

I read the above report, I have been in business for 30 years, and this doesn't surprise me in any way what so ever. The BBB uses complaints to practically blackmail business to join and pay their annual dues, which is an entirely different subject. Regardless, you would be shocked at the number of consumers that attempt to blackmail businesses who are viable or “on the radio”

I have no first-hand knowledge of what did or did not go on, but complaints can be expected if you are doing anything at all.

Southeastern Delivery, LLC – THE HYPE – “a successful home delivery grocery business, headquartered in Pensacola, FL.” Despite all the hype it is owned by Gary Calhoun per the BBB

I guess this is only an issue for someone who has never owned multiple businesses. For multiple businesses it is good to separate your enterprises and incorporate them individually. I am sure many of the people reading this right now own multiple corporations. The interesting part is that the home grocery business is a 1 Billion dollar a year industry project to grow to 85 Billion within 10 years. People are sick of the time wasted at the grocery store! South Eastern was started in Pensacola and delivering groceries in that area nearly a year before the Marketing Arm (MPB) was ever formed.

FTC SAYS: 50% OF A CHECK (OR VOUCHER = WALMART CARD) MUST COME FROM SALES TO END CONSUMERS WHO DO NOT BELONG TO THE PAY PLAN.

To provide educational clarity this is a pyramid scheme pure and simple. Why? You only fill positions (called pyramid head hunting) to collect money! Easy simple hunt heads, **DON'T SELL PRODUCT** in this case it is so pathetic it is not as the FTC calls it a "Fig Leaf" - So this matrix is a pure pyramid scam!

In my opinion, this is the only paragraph in the entire post that doesn't relate to 90% of the successful network marketing companies in the market place that have been operating for years! Again, I think this is from not really having a clear picture of how the comp plan works or some kind of personal vendetta.

SIDENOTE ...ONCE AGAIN THIS WAS WRITTEN PRIOR TO THE COMPANY INTRODUCING THEIR "RETAIL YOUR WAY TO SUCCESS" PROGRAM WHICH MAKES THE ENTIRE ARTICLE IN DESPARATE NEED OF A RETRACTION.

Consider this. Southern Delivery is delivering groceries to retail customers who are not part of MPB daily. As for MPB, some will join FREE only for grocery delivery making them retail customers, this reality alone prevents it from being a pyramid in my opinion. (We have as many free members (who just want the service) as paid at the time of this writing).

If you want to split hairs when someone enters the company they have the option to pre-pay for their groceries. They can order them immediately, or wait. Some people will attempt to build a business and become distracted or should never be involved marketing anything to anyone, technically becoming "retail customers" If the numbers used in this post are correct

“For every 100 people that join 14 get paid” then it is my understanding from a “legal prospective” the other 86 a technically customers.

CLOSING THOUGHTS

Again, I want to say how much I sincerely respect the job the guys do at MLM Watch Dog, but I found this entire post perplexing. I can understand their natural negativity towards a 2X2. I tend to agree with them because most of them just offer token digitally delivered products, but groceries, gas and Walmart Cards? It can't be much better than that!

What I find most appealing about this program is nobody can get hurt! What is the worst thing that can happen? You pre-pay for \$200 worth of groceries you end up eating! Think about it! That is the WORST possible outcome!

The other factors that are causing this program to explode across the country is

- * The compensation plan is very simple to understand!*
- * No special witch doctor juice, everybody eats*
- * No monthly auto-ship requirements*
- * No monthly sponsoring requirements, sponsor 2 and you are qualified for life.*
- * Awesome online video explains everything and our team upline team dose weekly webinars that are awesome every night at 8:00. <http://www.8PMWebinar.com>*

I guess the bottom line is I feel so good about the upside potential of this program I have shared it with my parents and kids. Hey, it might be gone tomorrow, but I don't think it will be, I just hope they can continue to keep up with the growth this program is going to continue to experience because the average person can use the website and duplicate quickly.

Side note: Since the time this was first written the company has moved into a new 10,000 Square Foot Office Facility, Added Staff, New Website, New Phone System and much more.

Who wouldn't invest \$200 to receive free groceries and gas for life? I think this is going to be a ton of fun, and Dawn and I are working on some real cool marketing tools for our team. So if somebody sent you to this confidential report get back with them now and tell them you are ready to roll. That would be my advice.

Traditional Network Marketers Are Scared of MPB

I have not seen this much of a stir about a network marketing company since Melaleuca was introduced 23 years ago. The more naysers nay, the more people they are ultimately sending to MPB. Every time I see a marketer rambling, paying no attention to the FACTS and sharing their negative opinions I have a flashback.

Everyone seems to be talking about how companies with a 2x2 comp plan are notorious for taking products with little or no value and throwing them into a cyclus which most would agree is a **cash generating comp plan with no equal**.

You know what; they are absolutely correct, but what on God's Green Earth does that have to do with gas, groceries and gift cards?

You cannot have a product with a more wide appeal to the masses than those **THEY ARE ALREADY BUYING EVERY MONTH AT WALMART!!** When you stop and think about this, there REALLY IS NO BETTER PRODUCT for network marketing than NAME BRAND GROCERIES & OTHER PRODUCTS THAT VIRTUALLY 100% OF THE POPULATION ARE ALREADY SPENDING MONEY ON AT WALMART EVERY MONTH ... Not to mention gasoline!

Here is another brain tweak you can go to Walmart and use your \$200 gift card to buy a \$200 pre-paid credit card that you can pay your cell phone bill, cable bill, electric bill or any other bill with!

When those few naysers out there try to connect the dots, and somehow equate the MPB product line to those of some cyclus programs of the past, the average person who can think on their own must be thinking "what a moron".

The truth is Traditional Network Marketers are scared and they should be! No telling how many of their downline members who are sick tired of not making money have already joined MPB and they know there will be many more to follow. The facts are the company has grown from 450 distributors to 17,000 in 2 months and they are expecting to add 40,000 new members in September according to a conference call I heard last week.

We have all heard that all new concepts/ideas go through 3 stages:

- 1) **RIDICULE** (I am all 4 this when it is based upon facts not, you know what they say about opinions)
- 2) **VIOLENTLY OPPOSED** (This is what happens when people start losing business or in this case distributors)
- 3) **OBVIOUS TO THE MASSES** (This were it becomes common knowledge that this new concept/ idea is valid as what happened with Melaleuca)

23 Years ago when Melaleuca started they were the first company to introduce the idea of auto-ship which today is used by virtually every company in the market. Not only that; they were also the first company to use bank draft payments for the monthly auto ship payment was.

Bank drafts had been used by insurance companies prior to this but no network marketing company had ever done it.

There was a great large number of network marketers (me included) that where consciously or unconsciously scared to death. I would never admit it at the time, but I thought what they were doing was pure genius, of course I would never say that then and tried to just stay neutral.

I had a side line that for months would not shut up about it. Illegal, access to people's bank records, can't force distributors to order products and on and on. He ultimately lost about 90% of his organization. One of his leaders had left and went to Melaleuca and he wouldn't shut up about it. So the more he blabbed the more curious his team became.

The exact same thing could be said about USANA when they brought the Binary comp plan mainstream! The naysayers couldn't stop babbling about it ultimately driving people to it. Arguably USANA has become one of the most successful companies in the industry. For the record I have never tried to hide the fact that I am not a fan of a Binary comp plan, but that is for another time.

Like Melaleuca introduced auto ship to the industry and Usana brought the binary comp plan mainstream I see the same thing potentially happening with MPB. No I don't have a crystal ball, and 90% of the network marketing companies could be gone tomorrow. I sincerely think MPB has the opportunity to re-write network marketing history for several reasons other than the comp plan.

- People have always come into network marketing to make money, and end up hanging around for the friendships. Ultimately people start a network marketing business to make money and in 30 years I have not seen a quicker, faster, easier way to do it.

- As I have already talked about there is no juice, potion, lotion or scum from the ocean to sell. Yes network marketing has always been on the cutting edge of new product trends and development, but the fact is you have to educated consumers and many times the products have to be sold. It cannot get better than NAME BRAND groceries, Clothes, personal care or other product that CONSUMERS ARE ALREADY SPENDING MONEY FOR EACH MONTH, and gasoline.

Do you understand?

I don't care how great your product is and how many triple blind studies done by Harvard University you have. Mom and Pop consumer doesn't care! In this economy or a booming one, IT CANNOT GET ANY BETTER.

- Low Risk / High Rewards It cracks me up how naysers act like people will lose their life savings!

What is the worst thing that can happen?

A person pre-pays for \$200 worth of groceries and \$10 PER YEAR for their website. They get no direction, support or direction from their upline so they quit and go online and place their grocery order PLUS shipping. THAT IS THE WORST POSSIBLE SCENARIO!

What is the upside potential sponsor 2 who sponsor 2 and you cycle and earn \$300 cash and \$200 Walmart gift card. Ladies and gentleman you spend **\$210 1 TIME!** With the companies new "sale your way to success program" you can join free and just retail if you want to do it the hard way.

If you enroll refer 2 who refer 2 you are already in profit. I sincerely believe most people with the right direction will do this in 30 days or less. Let's be real, if a person can't do this, they DO NOT BE INVOLVED IN ANY NETWORK MARKETING PROGRAM, THEY NEED TO FIND SOMETHING ELSE TO DO!

Upside? I sincerely believe if you provide the right training and support to your team, the potential to create \$300 dollars & a \$200 gift cards 24 hours a day, 7 days a week over a relatively short period of time is here. That is why our personal domain name is <http://www.300Dollars24-7.com>. Quite frankly if I didn't believe this opportunity offered SIX FIGURE MONTHLY POTENTIAL I wouldn't be doing it.

I could go on and on. The reality is traditional network marketing as it exists today with stair-step break away commission plans, Unilevels, and Binaries, make it too difficult for the average person to create income **quick enough** to stay in the program. People are no longer willing to buy into the 3-5 year game plan and it is our own fault as I predicted in an article I wrote about 15 years ago entitled "Cater to mediocrity or Inspire Greatness, that is the Question".

Like every company in the past 5 years has tried to duplicate the success of Xango and Mona via by introducing a new juice. ***Companies in the future with credible products will be using some sort of cycler comp plan.*** Just like auto ship is mainstream today cycle comp plans will be in the future.

But no one will ever be able to compete with NAME BRAND groceries, Clothes, personal care or other product that CONSUMERS ARE ALREADY SPENDING MONEY FOR EACH MONTH. Virtually all naysayers of auto ship programs eventually got involved in companies using auto ship. The same can also be said about Binary comp plans.

There is a very real possibility that the naysayers of cycle comp plans today will one day be involved with one. **The good part for MPB members is no product will ever be able to penetrate the market place at the level MPB is and will continue to do.**

Cycling comp plans are the future.

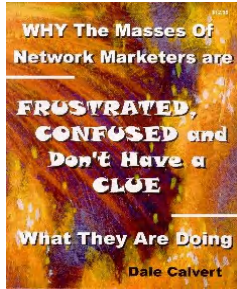

This why the company has exploded from 450 reps to over 22,000 in 90 days!

Real people "Get It".

Now back to the company and owner.

I feel like I have always been a good judge of people and seeing behind the curtain. The owner is saying all the right things, and there have been no red flags for me. The checks to our team are coming on time, and the company makes small improvements daily.

Most naysayers have never taken the time to really look at the companies long-term business model and how logical it is. I am not going to take the time to explain it here.

Walmart doesn't want to be in the grocery delivery business. So go where they are in areas MPB already has members, get trucks on the road and buy your groceries from Walmart.

But... that's just one city and our grocery delivery service is planning expansions all over the country. Imagine 5 cities... 10 cities... 50 cities!
